## **CELEBRATION DAY FOR GIRLS & FATHERS CELEBRATING DAUGHTERS FACILITATOR TRAINING TERMS & CONDITIONS**

### **1. Acceptance of Terms**

By accessing or enrolling in our courses, you agree to be bound by these Terms of Use, all applicable laws, and regulations.

### **2. Use License**

- Personal Use Only: You are granted a limited, non-transferable license to view/download course materials for personal, non-commercial use (except where specifically stated).
- Restrictions: You may not modify, copy, reproduce, republish, upload, post, transmit, or distribute training materials without explicit permission.
- No Sharing: Log-in credentials (where applicable) are for personal use only and must not be shared. Access may terminate upon violation of these rules.

### **4. Payments and Refunds**

1. Payment Terms: You agree to pay for course(s), including installment plans if applicable.
2. Refunds
  - a. No refunds will be considered except in the following circumstances:
    - i. If you request to cancel your place more than 28 days before the start of the training **and** the workshop is full **and** your place can be filled from a waiting list. In this case a refund of all payments received for the relevant training, minus a AU\$50 admin fee may be possible, on application. See 4.2.c re FOME packages.
    - ii. If you are sick/injured/pregnant & unable to attend the training **and** can provide a doctor's note **and** you request to cancel before the course commences. In this case a refund of any payments for CDG/FCD training made to date, minus a AU\$50 admin fee (or the deposit, whichever is greater), may be possible on application. See 4.2.c re FOME packages.

- iii. If we are unable to run the course **and** are unable to offer an alternative date within 18 months following receipt of your application **and** you are unable to wait for a future training. In this case a refund of any payments made for the training may be made on application. See 4.2.c re FOME packages.
  - iv. If we are unable to obtain two satisfactory references for you & you are thus deemed ineligible to join the training we will refund you any course fees paid minus a AU\$50 admin fee. See 4.2.c re FOME packages.
  - b. No refunds are possible in any circumstances once the course has commenced.
  - c. If you paid via a FOME package, and you meet one of the exceptions above then any payments made towards the reduced CDG/FCD fee (not including the full price of FOME) could be refunded on application, minus the AU\$50 admin fee. No refund for FOME will be offered once access to the online course platform has commenced.
  - d. Collection: We reserve the right to seek payment through debt collection services if installments are missed and you have commenced CDG/FCD training with us
3. Transfers: Transfer to a future training may be possible on request, depending on circumstances and are strictly at the discretion of the course leaders
